## Brand Your Event as Green with Valet Bike Parking

To Whom It May Concern:

The Marin County Bicycle Coalition's *Valet Bike Parking* service is a real value. It is a badge of honor in eco-friendly Marin to offer *Free Valet Bike Parking* at your event. People arriving by bicycle get right into your event, avoiding the hassle of looking for parking and walking great distances. In addition, your event is promoted by MCBC at no extra cost!

MCBC prints 2,500 *Valet Bike Parking* schedules, which list all the calendar year's Full Service events. This schedule is handed out at every event MCBC puts on and attends, and is sent to every new and renewing MCBC member (approximately 1,500 households). We also promote events with Full Service *Valet Bike Parking* on our website (www.marinbike.org), in our spring *Pedal Press* newsletter, in weekly emails to over 5,000 Bay Area cyclists, and with our new social media tools, including Facebook and Twitter.

This letter contains information on our Full Service options and Rack Rentals. If you choose one of our Full Service options, MCBC will provide all the staff and equipment to set-up, run and break down bike parking at your event. Events requiring staff must have paperwork submitted one month in advance.

To add your event to our annual schedule, complete the Event Information and Service Requirements forms below and returned to MCBC 30 days prior to your event.

## SERVICE FEES

<u>Full Service Large events</u>: \$450 first day + \$250 additional days Events expecting 70+ bikes – requiring our truck-towed bike rack system.

<u>Full Service Small events</u>: \$250 per day Events expecting up to 70 bikes – 5 racks provided.

<u>Bike Rack rental (nonprofit organizations only)</u>: \$150 per event Five racks (enough to park 70 bikes), tickets, and tape. Corral equipment may also be included as part of rental if available. Staffing not included. Rack delivery and pick-up not included. *Large and Small event fees* include the provision of bike parking equipment and staffing to maintain continuous on-site valets for the duration of the bike parking time period.

**Rack rentals** only include the <u>delivery and pick-up</u> of rented racks at your event site. MCBC will unload our equipment and re-load it post-event, but you are responsible for set-up and complete break-down for your event. Rental may also include use of other bike parking corral equipment (fencing, posts, sign cades, etc.) stored in our trailer on a first-come, first-served basis if MCBC has no event conflicts. Rack Rental does not include staffing for your event.

**Damage or Replacement:** Damage to any rack will result in a charge of \$50 per rack for repairs. Destroyed or missing racks will result in a \$350 charge for full replacement. Charges will appear on your post-event invoice.

We look forward to providing our green service at your event and helping you promote environmentally healthy habits to all event attendees. Please review the enclosed materials carefully and submit your bike parking service request to MCBC 30 days prior to your event.

## Bike Parking Service Requirements - 2016

MCBC requests your cooperation in providing the following items to ensure that your bike parking service is fully utilized by your event attendees.

- ✓ Requests for Valet Bike Parking need to be made at least 30 days prior to the event date. Events requiring staff must have paperwork submitted one month in advance.
- ✓ For Small and Large event service requests only, the MCBC logo should be included on all event promotional materials with a statement similar to "Secure bike parking will be provided by the Marin County Bicycle Coalition."
- ✓ Our Valet Bike Parking should be located at the event entry to provide the most visible and convenient parking for cyclists.
- ✓ Our Valet Bike Parking location should be shown on your event map to facilitate its use by your event attendees.
- ✓ All events require event passes for staff bathroom access.
- ✓ Damage to any rack will result in a charge of \$50 per rack for repairs.
- ✓ Destroyed or missing racks will result in a \$350 charge for full replacement.
- ✓ Full payment is due to MCBC within the month prior to your event; MCBC will submit an invoice for the amount due. *Cancellations must be made 30-days prior to your event or a 50% cancellation fee will be charged.*
